Accolades aside, Robert has an unwavering passion for representing those who have been seriously injured or killed. His passion is proven by his results. In the courtroom, Robert has served as lead and co-lead counsel in obtaining significant verdicts in extremely challenging cases. A few recent examples include the following:

- \$14.8M Verdict for wrongful death and personal injury in a natural gas explosion in one of the most conservative venues in the United States.
